TUSK - \$149 Annual Fee

Program Includes:

- Membership valid Mon-Thurs anytime, Fridays before 12pm, Holidays not included
- Membership valid 1 year from purchase date
- Prices subject to change without notice. Membership not valid with outside tournaments
- Members and guests must double up on golf carts at all times



TUSK VIP - \$249 Annual Fee

Program Includes:

- \$20 golf fee for 18 holes or \$15 golf fee for 9 holes - Monday thru Friday anytime (except Holidays)
- \$25 golf fee for 18 holes or \$20 golf fee for 9 holes - Saturdays after 11am, Sundays and Holidays
- Pay only \$39 golf fee to play on Saturday mornings
- Free round of golf upon sign-up (\$49 value)
- Membership valid Sun-Fri anytime, Saturdays after 11am
- Membership valid 1 year from purchase date
- Prices subject to change without notice. Membership not valid with outside tournaments
- Members and guests must double up on golf carts at all times

Contract and Obligation Agreement

By signing this agreement, the Tusk member agrees to fulfill a minimum one (1) year obligation. The Tusk member must provide proper notice of termination in the form of a written statement. Termination of agreement prior to one (1) year fulfillment period will automatically result in a penalty equal to the amount of the remaining monthly fees inside of a said one (1) year obligation, or 3 months worth of fees (whichever is less). The Tusk member also agrees that upon termination of agreement they are not eligible for reinstatement until a period of no less than twelve (12) months has passed after the day of termination. Stonebridge Meadows Golf Club reserves the right to terminate this contract at any time and for any reason.

Terms & Conditions of Membership

1. The applicant warrants and represents to the Management that the enclosed information is true and correct. This application will not be acted upon unless fully completed, signed and accompanied by a payment for the required fees. The applicant understands that membership in Stonebridge Meadows Golf Club and any privileges to use the club facilities shall terminate as defined herein.
2. The applicant acknowledges and agrees to be bound by the terms and conditions thereof, as amended from time to time, in the sole discretion of Stonebridge Meadows Golf Club. Membership privileges may be terminated for failure to abide by any membership conditions.
3. The applicant hereby acknowledges that membership in Stonebridge Meadows Golf Club is not an investment in Stonebridge Meadows Golf Club, nor does it provide an equity or ownership interest in Stonebridge Meadows Golf Club facilities. Stonebridge Meadows Golf Club reserves the right, in its sole and absolute discretion, to restrict or otherwise reserve the golf facilities for maintenance, tournament play and other special events from time to time. The payment of membership fees is required to acquire and maintain membership privileges. With exception of these membership charges, members are not subject to any liability or assessment for the cost and expenses of ownership or management of Stonebridge Meadows Golf Club.
4. The applicant acknowledges that this membership pertains to the individual only and does not include spouse, children or any other family members.
5. The applicant acknowledges that any and all fees relating to this membership are non-refundable & non-transferable under any circumstances.
